### **VET NOTES** Sharon Hoofnagle D.V.M. Colic in Horses- Is It Urgent?

Dr David Freeman, head of the Dept of large animal surgery at the University of Florida presented information on equine colic referral at the 2022 Amer. Assoc of Equine Practitioners Convention.

Colic is a generalized term for abdominal pain. It could be something simple like gas colic or it could be a life-threatening strangulation. Humans often get upset gastro-intestinal tracts because of our diets, dogs do also., but upset GI tracts are not normal for the horse, it is always serious.

Dr Freeman cautions against delaying referral to a surgical facility. Freeman attributed delay to several owner and trainer misconceptions about colic surgery. "They think it is rarely successful; the horses are never the same; or a sick horse can't handle the travel, surgery or anesthesia. Statements like" surgery is not an option". could be, in part, due to cost as a major issue. However, it is not uncommon for an owner's sentiment to change as the horse's progression worsens. However, by then too much time could have elapsed and the window of "golden opportunity" for colic surgery has passed." "It is important to get a horse to surgery before the bowel experiences irreversible changes.

I agree with Dr Freeman. Most colics do not require surgery and the horse responds well to medical treatment at home. But if they do not improve, we need to get the horse to the surgery center for observation before they deteriorate.

So here are some guidelines. Any sign of a colic, even if mild like off feed, lying down, is a concern. Call your veterinarian for advice. More serious signs would be rolling repeatedly, pacing, call your vet, emergency. Don't administer any medication if your vet can get there within an hour. Medications will make the horse look better but will not correct the problem. The horse could worsen because the underlying problem hasn't been corrected. An example of this is an impaction colic. Owners have been known to administer painkillers for days, turning an easily treatable condition into a lethal one. It is easier for the veterinarian to assess the seriousness of the condition if the horse is not medicated.

Here is the important point: if the horse is seriously ill we may recommend the horse go to a surgical facility for observation and treatment. They may not need surgery, but they will be on site if it is needed. Often it takes some time to prepare for transport and the surgery may be some distance away. The referral center may have several patients that come in the same day. The surgical team may need to be called in.

So what if you are on a trail ride? This is covered in my wilderness first aid class in depth, but I will try to simplify it here. I recommend the trail rider carry flunixin in their saddle bags. However don't give it at the first sign of colic. The most common cause of rolling or pawing on the trail is an itchy horse crossing a sandy area. Keep moving and give the horse a few minutes to see what happens. Colic tends to be spasmodic. If signs re-occur in 10-15 minutes you need to re-think. If you are in a dangerous area, cliffs, bridges, etc. go ahead a give a dose. I recommend getting a horse out and headed for home if they need the painkiller. They may look improved due to the meds but If you wait too long you may have trouble getting them out.

In summary, Dr. Freeman urged equine practitioners to educate owners and caretakers about colic surgery well in advance of a necessary situation. He said veterinarians also should discuss the possibility of acquiring equine surgical insurance. Teamwork between the owner, the referring DVM and the surgeon helps to resolve misconceptions about cost estimate and prognosis of surgery, as well as avoiding duplication of procedures. Modern surgery is highly successful. Even older horses can recover well but all issues should be discussed early in the event of any serious health issue.

Our guest speaker was introduced: Steve Avila from Whatcom City Zen. He described a program he developed to protect trailheads from vehicle prowls.

The Whatcom City Zen is a volunteer non-profit organization, (501(c)3) that rotates thru Whatcom County trail-heads to deter vehicle prowls. Volunteer's sign up for 30 minutes shifts. A canopy, chairs, and snacks encourage interaction with trail users and act as a deterrent to criminal activity. It also encourages community interaction with both trail users and neighbors. They also have neighborhood trash pick-ups and graffiti removal. Steve currently subsidizes much of the work.

Volunteers can sign up for shifts by emailing: whatcomcityzen@gmail.com. You can also sign up to receive notification of trailhead surveillance.

The sessions are fun, volunteers often stay longer than they planned. visiting with folks. Folks are encouraged to sign up for sessions, maybe then enjoy a ride knowing their rig is being protected.

### **Business meeting**

**Trail committee**: The Spring Ride is this Saturday. A ride will be led out at 9:30. The trail will be marked. Potluck will be at noon. Cindy will bring paperwork for sign-in. Andy, Melinda, and Sage will tag on Friday.




